Welcome; Presentation of October 2017 Minutes

Discussion: Mrs. Hrach gave an update on the result of the fall FSA for Algebra I which were outstanding. Currently only 12 students need to pass the exam. The PERT given in September resulted in 11 of 16 students with a passing score. Leaving a small number of students to re-test. The first semester testing schedule along with the spring test schedule were distributed. Semester 1 exams will begin on December 18, for Periods 1 & 2, December 19, for Periods 6 & 7, December 20, for Periods 3 & 4, and December 21, for period 5. A reminder that exams may not be taken early. All make up exams will be giving immediately following the return from the winter break on January 8, 2018. Some exams are paper & pencil, others are computerized. Exams may be created by the district or the teacher dependent upon the subject matter. Honors exams differ from standard exams. The spring texting window will begin the week of March 26, 2018, and go through the last day of school. Test will include the FSA exams for English Writing and Reading, FSA Algebra 1 retakes, Mathematics, Science, and History. Following will be the AP Exams, Senior Exams, and Final Exams, which will conclude on the last day of school. Again exams may not be taken early. All makeups will be on May 24, and the following week. The last day to make up an exam will be June 1. A sign up genius will be going out to recruit testing proctor volunteers.
