

Parental Liability Waiver, Release and Indemnity ("Waiver")

(non-UNF-sponsored activity on UNF campus—University Center)

THIS AFFECTS YOUR LEGAL RIGHTS.
PLEASE READ CAREFULLY BEFORE SIGNING BELOW.

I am the parent or legal guardian of _____ ("child"), who is or will be under the age of eighteen (18) at the time of the Activities. I have full authority to sign this Waiver on my child's behalf and bind the child all persons claiming through him/her. I hereby give permission for our child to participate in the Ponte Vedra High School JRSR Prom ("Activities") on May 6th, 2017, sponsored or conducted by Ponte Vedra High School ("Sponsor") at the Adam G. Herbert University Center ("University Center") on the campus of the University of North Florida in Jacksonville, Florida.

I acknowledge that, though the University Center is part of the University campus, the University does not conduct or sponsor the Activities and the University Center is being used for the Activities by Sponsor under a separate agreement with the University. Sponsor is not related to the University.

I know the dangers, hazards, and risks of the Activities. In consideration of the child being permitted to participate in the Activities, on behalf of the child, myself, the child's family, heirs, and personal representatives, I agree to assume all risks and responsibilities in connection with the child's participation in the Activities, the child's transportation to and from the Activities, the child's presence on the University campus, and any act undertaken by the child or any other person whatsoever.

I waive any and all claims for any harm, injury, damage, claims, demands, actions, judgments, costs (including all attorneys' fees) and expenses of any nature (collectively "Claims") that I or the child, or anyone claiming through me or the child, may have or that may hereafter accrue to the child or to me, arising out of or related to any loss, damage or injury, including but not limited to suffering and death (collectively, "Injury"), that may be sustained by the child or any property belonging to the child or to me, and I release and discharge The University of North Florida Board of Trustees and the State of Florida, their officers, employees, agents, and representatives ("Released Entities") from all Claims for Injury, whether caused by the negligence or carelessness of the Released Entities or otherwise.

Additionally, I agree to indemnify and hold harmless Released Entities from all Claims for Injury.

I understand that Released Entities do not have medical personnel available at the location of the Activities. I grant permission for Released Entities to authorize emergency medical treatment at an emergency care facility, if available, and that any such authorization shall be subject to terms of this Waiver. I understand and agree that Released Entities are not responsible for any Injury that arises out of or in connection with any such authorized emergency medical treatment. I understand that the Released Entities do not provide accident/health insurance for us or our child, and I assume personal and financial responsibility for any such medical care and treatment.

The University of North Florida is a constituent member of the Florida State University System established under the Constitution of Florida administered by The University of North Florida Board of Trustees, a public body corporate. This Waiver is governed by the laws of the State of Florida.

I have read this Waiver and, by signing below, agree to be bound by it. I have had an opportunity to review with legal counsel any portion of this Waiver I do not understand.
